Use of Innovative Consumer Health Solutions to Manage Chronic Disease Panel

Explore three innovative solutions that use simple, consumer-grade technology, such as smartphones and web portals, to empower patients to self-manage chronic conditions and reduce the likelihood of needing to visit emergency departments and/or require hospital admission. Developed in British Columbia, the solutions are: the Mobile Digital Access to a Web-enhanced Network (mDAWN) project for diabetes patients and their caregivers; a virtual cardiac rehabilitation program; and a WelTel mobile application and model of care for managing the health of HIV and tuberculosis patients.



Strengthening the Circle of Care: First Nations Personal Health Record

The individual, family and community are key pillars in the circle of care within First Nations health programs. Rather than reinforce a model of passive patients, First Nations build their approach to care around an empowerment philosophy where the

patient is an active member. Learn how the *Strengthening the Circle of Care* project brings consumer health benefits to patients and providers in the largest First Nation in British Columbia, Cowichan Tribes, through use of a Canada Health Infoway-certified personal health record solution.

e-Health Enabled Aged-Care Nursing for Rural and Regional Australia

Presenter: Helga Merl, The University of Newcastle, Australia

Explore integratedliving, Australia's innovative nurse-led memory wellness clinics and telehealth service for rural and regional communities. Learn how Registered Nurses access best practice dementia care, including cognitive assessment, through apps installed on iPads. A video case conference with integratedliving RNs, Nurse Practitioners and GPs identifies those at risk of dementia and consumers are then scheduled into the "pop-up" memory clinic for telehealth assessment. This initiative debunks the



belief that older people find technology overly challenging and shows they can be motivated to monitor multiple chronic health conditions simultaneously to improve their healthcare and well-being.

Assessing Smartphone Application Usage with Google Analytics and Other Measures

Presenter: Dr. Alexander Logan, Mount Sinai Hospital

This session focuses on a mobile health system that supports self-management activities of patients with advanced chronic kidney disease. Learn about a study demonstrating that patients maintained high-level use of a smartphone application throughout the six-month study period, suggesting acceptance and sustainability. Sixty percent of patients in the study had never used a smartphone
